BACKGROUND

The City of Hallandale Beach (CITY) has requested that Hazen and Sawyer (CONSULTANT) provide the inspections personnel that were originally assumed to be provided by the CITY under the original scope of work. This amendment adds the daily inspection services during active construction to CONSULTANT's tasks and deletes the services from the CITY's responsibilities.

REVISE TASK 4 – CONSTRUCTION SERVICES

Task 4 - Construction Services

The CITY will provide overall project management and coordination between the CITY, Contractor and CONSULTANT. The ~~CITY~~ CONSULTANT will provide ~~for continuous~~ daily and periodic inspection services of the HSP and associated equipment installation. Services to be provided by CONSULTANT shall be as follows:

REVISE TASK 4.6 – On-Site Observations from the original SCOPE OF SERVICES:

4.6 On-Site Observations: CONSULTANT shall perform daily and periodic site-visits during active construction by civil, mechanical, electrical, structural, and instrumentation engineers during construction to confirm that the work is in substantial compliance with the contract documents, plans and specifications. CONSULTANT shall document construction in daily, written reports and digital photographs. CONSULTANT will electronically transmit the daily reports to the CITY on a periodic basis and upon request. The CITY and CONSULTANT will communicate to determine the necessary daily site visits during the construction period.

DELETE Assumption 4 from the original SCOPE OF SERVICES

REVISE Assumption 22 from the original SCOPE OF SERVICES:
