FOR DAILY THE INSPECTION SERVICES FOR CITY HALLANDALE BEACH WATER TREATMENT PLANT HIGH SERVICE PUMP REPLACEMENT PROJECT: APPROVING AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE NECESSARY AGREEMENTS TO EFFECTUATE THE CHANGE ORDER; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on January 25, 2017, the City Commission approved Resolution 2017-06 awarding RFP # FY2015-2016-025 CCNA Design Service Pumps and Transfer Pumps at the City's Water Treatment Plant to Hazen and Sawyer, P.C. (Hazen and Sawyer); and

WHEREAS, the scope of work for RFP # FY 2015-2016-025 CCNA Design High Service Pumps provides that the consultant would be available to the City of Hallandale Beach for requested on-site reviews and inspections throughout the project; and

WHEREAS, on March 15, 2017, the City adopted Resolution No. 2017-32 authorizing the City Manager to execute an agreement (Agreement) with Hazen and Sawyer pursuant to RFP # FY 2015-2016-025 CCNA Design High Service Pumps and Transfer Pumps for design, permitting, and assistance with bidding and construction oversight assistance, including inspections, for the replacement of the high service pump stations; and

WHEREAS, the Agreement stated that in addition to the inspection services performed by Hazen and Sawyer, the City would provide daily inspection services for the construction of the High Service Pumps; and

WHEREAS, due to staffing changes within the past year in the City's Public Works Department, the City is unable to perform the daily inspection services as stated in the contract; and

39	WHEREAS, City Administration has determined that it is in the best interest of the		
40	City to amend the Agreement to reflect that Hazen and Sawyer will conduct daily		
41	inspection services during active construction of Water Treatment Plant High Service		
42	Pumps Replacement Phase 1 for an additional amount not to exceed one hundred ter		
43	thousand five hundred dollars (\$110,500). Hazen and Sawyer will conduct these		
44	inspections during active construction with civil, mechanical, electrical, structural, and		
45	instrumentation engineers. The City will not be responsible for daily inspections or reports		
46	and		
47	WHEREAS, pursuant to Section 23-12 of the City Code of Ordinances, change		
48	orders in excess of \$50,000 require the approval of the City Commission; and

50	WHEREAS, the City Administration recommends the Mayor and City Commission		
51	authorize the City Manager to execute a change order agreement with Hazen and Sawye		
52	in an amount not to exceed one hundred ten thousand five hundred dollars (\$110,500).

54	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY		
55	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

57	SECTION 1. The foregoing "Whereas" clauses are hereby incorporated herein.

59	SECTION 2. Authorization of City Manager. The Mayor and City Commission		
60	hereby authorize the City Manager to execute a change order agreement with Hazen and		
61	Sawyer in an amount not to exceed one hundred ten thousand five hundred dollars		
62	(\$110,500) for additional daily inspection services during the construction of the High		
63	Service Pumps Replacement Phase 1 at the City of Hallandale Beach Water Treatment		
64	Plant.		
65	SECTION 3. This Resolution shall take effect immediately upon its passage and		
66	adoption.
