

RESOLUTION NO. 2018 – 149

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPROVING THE COMMUNITY PARTNERSHIP GRANT FOR THE HALLANDALE MAGNET HIGH SCHOOL SATURDAY ACADEMIC AND ENRICHMENT CAMP FOR THE REMAINDER OF THE 2018-2019 SCHOOL YEAR; AUTHORIZING THE CITY MANAGER TO EXECUTE AGREEMENTS TO EFFECTUATE AWARD OF FUNDING AND UTILIZE FUNDS FROM THOSE ALLOCATED FOR COMMISSION TRAVEL; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission established the Community Partnership Grants program to provide Non-profit and Community Based organizations with funding necessary to support their community programs that support and provide services to the residents of Hallandale Beach; and

WHEREAS, the Hallandale Magnet High School Saturday Academic and Enrichment Camp was funded by the City under the Community Partnership Grants Program for a three-year period. The initial 12-month period ran from October 1, 2017 through September 30, 2018; funding allocated for this first year was \$50,000; and

WHEREAS, CPG grant renewals are contingent upon available funding and allocation within the fiscal year budget. CPG applicants must be a registered 501(C)(3) non-profit organization with the IRS; must have an active corporate status with the State of Florida; and must be current on all financial obligations (including taxes) with the City; and

WHEREAS, for the second year, funding in the amount of \$33,333 was recommended by staff as there were budgetary constraints within the Community Partnership Grants Program. However, this funding allocation was eliminated by the City Commission during the August 27, 2018, FY19 Budget Workshop as a cost containment measure necessary to provide a balanced budget; and

WHEREAS, Commissioner Lima-Taub suggests utilizing funds from the City Commission's travel allowance, with the exception of the Mayor, and requested this item be brought forth for discussion and consideration.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. City Commission Approval of Community Partnership Grant to Hallandale Magnet High School. The Mayor and City Commission hereby approve award of the Community Partnership Grant to the Hallandale Magnet High School Saturday Academic and Enrichment Camp for the remainder of the 2018-19 school year in a total amount not to exceed twenty thousand (\$20,000) dollars, to be funded equally from the travel allowance of all commissioners with the exception of the Mayor.

SECTION 2. City Manager Authority. The City Manager is authorized to execute the Agreements to effectuate the award for funding.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
