L4	WHEREAS, the City Commission established the Community Partnership Grants
L 5	program to provide Non-profit and Community Based organizations with funding
L6	necessary to support their community programs that support and provide services to the
L7	residents of Hallandale Beach; and

L9	WHEREAS, the Hallandale Magnet High School Saturday Academic and
20	Enrichment Camp was funded by the City under the Community Partnership Grants
21	Program for a three-year period. The initial 12-month period ran from October 1, 2017
22	through September 30, 2018: funding allocated for this first year was \$50,000; and
23	
24	WHEREAS, CPG grant renewals are contingent upon available funding and
25	allocation within the fiscal year budget. CPG applicants must be a registered 501(C)(3)
26	non-profit organization with the IRS; must have an active corporate status with the State
27	of Florida; and must be current on all financial obligations (including taxes) with the City
28	and
29	
30	WHEREAS, for the second year, funding in the amount of \$33,333 was
31	recommended by staff as there were budgetary constraints within the Community
32	Partnership Grants Program. However, this funding allocation was eliminated by the City
33	Commission during the August 27, 2018, FY19 Budget Workshop as a cost containment
34	measure necessary to provide a balanced budget; and

37	WHEREAS, Commissioner Lima-Taub suggests utilizing funds from the City		
38	Commission's travel allowance, with the exception of the Mayor, and requested this item		
39	be brought forth for discussion and consideration.

41	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY		
42	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

44	SECTION 1. City Commission Approval of Community Partnership Grant to		
45	Hallandale Magnet High School. The Mayor and City Commission hereby approve		
46	award of the Community Partnership Grant to the Hallandale Magnet High School		
47	Saturday Academic and Enrichment Camp for the remainder of the 2018-19 school year		
48	in a total amount not to exceed twenty thousand (\$20,000) dollars, to be funded equally		
49	from the travel allowance of all commissioners with the exception of the Mayor.

51	SECTION 2. City Manager Authority. The City Manager is authorized to		
52	execute the Agreements to effectuate the award for funding.

54	SECTION 3. Effective Date. This Resolution shall take effect immediately upon		
55	its passage and adoption.
