Background:

for your review and recommendations is the draft City of Hallandale Beach 2019 State Legislative Program. The draft is based on past City Commission directive and new issues recommended by staff.

Why Action is Necessary:

Action by the City Commission will result in the adoption of the City's State Legislative Program. The Legislative Program establishes the City's legislative goals, gives direction to our lobbying firm, Ballard Partners, Inc., and provides a City Commission – authorized list of issues for the members of the Broward Delegation and other legislators during the 2019 Legislative Session.
