

## RESOLUTION NO. 2018-005

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPOINTING COMMISSION MEMBERS AS CITY REPRESENTATIVES TO THE BROWARD LEAGUE OF CITIES, FLORIDA LEAGUE OF CITIES, AND THE NATIONAL LEAGUE OF CITIES FOR THE 2019-2020 TERM; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, annually, the Mayor and City Commission appoint Officers/Directors, Voting Delegates and/or Alternates to represent the City of Hallandale Beach at the Broward League of Cities, Florida League of Cities and National League of Cities; and

**WHEREAS**, due to changes to the commission resulting from the recent election, it is necessary for the City Commission to appoint new voting delegates for the Florida League of Cities, and National League of Cities; and

**WHEREAS**, the Broward League of Cities' by-laws require that the Mayor and City Commission appoint a Director, an Alternate and a Second Alternate to the Board of Directors; and

**WHEREAS**, the Florida League of Cities' by-laws require the appointment of a voting delegate and an alternate to attend and vote at the annual business session; and

**WHEREAS**, the National League of Cities' by-laws require the appointment of a voting delegate, and one (1) alternate, (if desired) to attend and vote at the annual business meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
