20	WHEREAS, Commissioner Lima-Taub's comments promote bigotry and fuel hatred. By
21	vilifying a government official for her religious beliefs and accusing her of being a potential terrorist
22	willing to murder other government officials without evidence, she has created a hostile
23	environment for the City's Muslim residents; and
24	
25	WHEREAS, instead of apologizing for her remarks, Commissioner Lima-Taub has
26 27	doubled down, even going so far as demanding an apology from Congresswoman Tlaib; and
28	WHEREAS, the City of Hallandale Beach strives to be an inclusive community which
29	recognizes that Muslims, and people of all faiths, are part of the fabric of this country; and
30	
31	WHEREAS, policy disagreements with any government official should be resolved
32	through elections and debate, not by promoting a racist stereotype that all Muslims are terrorists;

35	WHEREAS, the Mayor and City Commission of the City of Hallandale Beach wish to
36	denounce the Islamophobic comments of Commissioner Lima-Taub, demand an apology on
37	behalf of Congresswoman Tlaib and the citizens of Hallandale Beach, and formally censure her
38	for promoting bigotry, fueling hatred and creating a hostile environment for the City's Muslim
39	residents.

48	Congresswoman Rashida Tlaib and the citizens of Hallandale Beach and formally censure her
49	for promoting bigotry, fueling hatred and creating a hostile environment for the City's Muslim
50	residents.

52	SECTION 3. Effective Date. This Resolution shall take effect immediately upon its
53	passage and adoption.
