## **Background:**

During the commission workshop meetings of February 13, 2017, March 13, 2017 and April 17, 2017 the City Commission reviewed the composition, powers and responsibilities of all City Advisory Boards and Committees. The Mayor and the City Commission determined that it is in the best interest of the residents of the City to establish and codify general rules applicable to advisory boards and committees, and to bring the Boards and Committees into compliance with

the new general governing rules for advisory boards and committees, pursuant to Ordinance 2018-012 (Exhibit 1) and Ordinance 2018-013 (Exhibit 2).

All members of boards and committees, including alternate members, shall be appointed by a majority vote of the city commission. At any given time, board members may not serve on more than one board and one committee or on two boards or on two committees.

The following Boards/Committees below require reappoint of current members or new appointments.

## **Current Situation:**

On May 16, 2018 the City Commission adopted Ordinance 2018-012 (Exhibit 1) and Ordinance 2018-13 (Exhibit 2) to provide regulations relating to Advisory Boards and Committees. The members and alternate members of all boards and committees shall serve at the pleasure of the city commission and shall be appointed for terms of approximately two years, with terms expiring on the date of the city Commission organizational meeting following each city commission election. Appointees serve at the pleasure of the nominating commissioner or other appointing authority. If the nominating Commissioner vacates his or her office for any reason, the terms of respective Advisory Board or Committee member nominated by that Commissioner shall terminate at the same time the Commissioner's office is vacated. However, each member and alternate member shall continue to serve until a successor is appointed. All members and alternate members are eligible for reappointment.

On December 11, 2018 the City Commission received the Advisory Boards and Committees Handbook (Exhibit 1) in which provided an introduction and overview and outlined the duties and responsibilities of all the Advisory Boards and Committees. The City Clerk's office has received Boards and Committees applications from Hallandale Beach residents (Exhibit 5a-5F).

## **Proposed Action:**

Direction from the City Commission to reappoint or appoint members to the Beautification Advisory Board, Civil Service Board, Education Advisory Board, Historic Preservation Board, Parks & Recreation Advisory Board, Planning & Zoning Board, and the Public Transportation, Traffic and Parking Advisory Board with vacant and/or expired terms.
