25	public expense against matters arising out of the performance of their public duties and while		
26	serving a public purpose.

39	Commission direct the City Manager to take all necessary steps to effectuate this resolution and			
40	direct the Clerk to cause a copy of this resolution to be forwarded to all appropriate parties.
