15	changing Florida so that no one suffers harassment or discrimination on the basis of their

18	WHEREAS, City Commissioners are allocated certain funds for city-related travel		
19	and training, which, if unused, are paid out to the commissioners at the end of the fiscal		
20	year; and

22	WHEREAS, Vice Mayor Sabrina Javallena has requested that the Commission		
23	authorize an advance payment of her travel fund monies to fund a donation to Equality		
24	Florida; and

26	WHEREAS, the Mayor and City Commission hereby authorize City Administration		
27	to process an advance payment of two thousand five hundred (\$2,500) dollars from Vice		
28	Mayor Javallena's travel allowance to be paid to Equality Florida.

30	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY		
31	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

33	SECTION 1. The foregoing "Whereas" clauses are hereby incorporated herein.

35	SECTION 2. The Mayor and City Commission hereby authorize City		
36	Administration to process an advance payment of two thousand five hundred (\$2,500)		

37	dollars from Vice Mayor Javellena's travel allowance to be paid to Equality Florida. The		
38	payment shall be processed in accordance with all payroll and tax regulations.
