WHEREAS, the Board of Directors of the HBCRA desires to establish the Commercial Business Mural Program.

NOW, THEREFORE, BE IT RESOLVED BY THE CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY:

- Section 1. Recitals. The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.
- Section 2. <u>Establishment of the Commercial Business Mural Program</u>. The Commercial Business Mural Program is hereby established.
- Section 3. <u>Implementation of Commercial Business Mural Program</u>. The Executive Director is hereby authorized to take all steps necessary and appropriate to implement the Commercial Business Mural Program including the policies and application process set forth in the Agenda Cover Memo, and the Executive Director is hereby authorized to appropriate and expend all Commercial Business Mural Program related expenses that do not to exceed the spending limits of the Executive Director; expenditures which exceed the Executive Director's spending limits shall be brought back before the Board of Directors of the HBCRA for approval.
 - Section 4. Effective Date. This resolution shall take effect immediately upon approval.
