BARBARA** 6 7 FERGUSON IN THE AMOUNT OF \$4,539.30; AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE THE CHANGE 8 9 ORDER: AUTHORIZING THE EXECUTIVE DIRECTOR TO 10 TAKE ALL STEPS NECESSARY AND APPROPRIATE TO IMPLEMENT THE CHANGE ORDER; AND PROVIDING AN 11 EFFECTIVE DATE. 12

WHEREAS, the Board of Directors of the Hallandale Beach Community Redevelopment Agency ("HBCRA") previously established the Replacement Home Program which, pursuant to the current HBCRA Policy Manual, adopted in November 2013, provides a low interest or interestfree loan up to \$150,000 to single-family homeowners when it has been determined (by way of the inspection as part of the preliminary loan approval process) that the necessary repairs to their property to bring it up to code will exceed 50% of the assessed value of the property; and

WHEREAS, pursuant to Resolution No. 2017-26 CRA, Board of Directors of the HBCRA
approved a one-time exception to the policy and approved a Replacement Home Program Ioan
to Barbara Ferguson (applicant) in an amount not to exceed \$190,000; and

WHEREAS, in order to provide the applicant with a replacement home that is completed with aesthetically appealing landscaping with a walkway from the driveway to the front porch, additional funding in the amount of \$4,539.30 from the Replacement Home Program is needed; and

WHEREAS, the Board of Directors of the HBCRA desires to approve additional funding in
the amount of \$4,539.30 from the Replacement Home Program to complete the replacement
home for Barbara Ferguson (applicant).

NOW, THEREFORE, BE IT RESOLVED BY THE CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY:

Section 1. <u>Recitals</u>. The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.

33 Section 2. <u>Approval of Additional Funding from Replacement Home Program</u>. The 34 additional funding in the amount of \$4,539.30 from the Replacement Home Program to complete 35 the replacement home for Barbara Ferguson (applicant) is hereby approved. Such funding is not 36 part of the Replacement Home Program Ioan. Section 3. <u>Execution of Change Order</u>. The Executive Director is hereby authorized to
execute the Change Order in the amount of \$4,539.30 for the landscaping and walkway from the
driveway to the front porch for the replacement home for Barbara Ferguson (applicant).

40 Section 4. Implementation of Change Order. The Executive Director is hereby authorized 41 to take all steps necessary and appropriate to implement the terms and conditions of the Change 42 Order in the amount of \$4,539.30 for the landscaping and walkway from the driveway to the front 43 porch for the replacement home for Barbara Ferguson (applicant) including the disbursement of 44 such funds.

45 Section 5. <u>Effective Date</u>. This resolution shall take effect immediately upon approval.
