17	Bank has been in effect since July 1, 2008, the expiration date for the agreement was
18	June 30, 2013, with an option to extend for an additional five (5) one (1) year terms; and

20	WHEREAS, the expiration date for the agreement coincided with the City's
21	implementation of the Enterprise Resource Planning (ERP) system, and as banking
22	services having evolved, the City has determined it is in City's best interest to test the
23	market for banking services which would best fit the needs of the City; and

25	WHEREAS, On December 9, 2013, RFP # FY2013-2014-004, Banking Services
26	was released, and five (5) responses were received on January 6, 2014; and

28	WHEREAS, the evaluation committee has reviewed all responses received and
29	recommend City Commission award of RFP #FY2013-2014-004, Banking Services, to
30	SunTrust Bank as the highest ranked firm and request authorization to negotiate and
31	execute an agreement with SunTrust Bank, and
32	MHEREAS the City Administration request authorization to pogetiate and execute
33	WHEREAS, the City Administration request authorization to negotiate and execute an agreement with the highest ranked firm, SunTrust Bank in substantially the same form
