12 13 14 15	WHEREAS, The mission of the Hallandale Beach Community Redevelopment Agency ("HBCRA") is to promote economic development and enhance the quality of life by eliminating and preventing slum and blighted conditions through the facilitation of community partnerships, business growth, job creation, and neighborhood rehabilitation; and
16 17 18	WHEREAS, at a duly noticed meeting of the Board of Directors of the HBCRA held on February 11, 2019, the Board of Directors of the HBCRA adopted Resolution No. 2019-007 CRA establishing the Commercial Business Mural Program; and
19 20	WHEREAS, the Board of Directors of the HBCRA desires to modify certain polices of the Commercial Business Mural Program.
21 22	NOW, THEREFORE, BE IT RESOLVED BY THE CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY:
23 24	Section 1. <u>Recitals</u> . The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.
25 26 27 28	Section 2. <u>Expenditures</u> . The Executive Director is hereby authorized to appropriate and expend all Commercial Business Mural Program related expenses that do not to exceed \$50,000; expenditures which exceed \$50,000 shall be brought back before the Board of Directors of the HBCRA for approval.
29 30 31 32 33	Section 3. <u>Selection of Mural Artists</u> . Due to the subjective nature of art, and the fact that a property owner may decide to select a specific type of artist in order to do a specific type of mural, the Executive Director is hereby authorized to approve the selection of artists on a case by case basis, and waive the three quotes procurement criteria on a case by case basis as needed.
34 35 36	Section 4. <u>Modification of Policies and Application Process</u> . The Executive Director is authorized to modify the policies and application process of the Commercial Business Mural Program provided that any modifications that exceed the authority of the Executive Director as

set forth in the HBCRA By-Laws shall be brought back before the Board of Directors of the HBCRAfor approval.

Section 5. Implementation of Modifications to Certain Polices of the Commercial Business
 Mural Program. The Executive Director is hereby authorized to take all steps necessary and
 appropriate to implement the modifications to the policies of the Commercial Business Mural
 Program set forth herein.

43 Section 6. <u>Conflicts</u>. In the event of any conflicts between this resolution and Resolution
 44 No. 2019-007 CRA, this resolution shall control.

45 Section 7. <u>Effective Date</u>. This resolution shall take effect immediately upon approval.
