9 10	WHEREAS, access to civic life by people with disabilities is a fundamental goal of the
11	Americans with Disabilities Act (ADA); and
12	
13	WHEREAS, the City of Hallandale Beach is fully committed to providing equitable access
14	to the City's programs and services, including digital content posted on the City's websites and
15	social media communications. and
16	
17	WHEREAS, governmental entities must ensure effective communication including the
18	provision of necessary auxiliary aids and services so that individuals with disabilities can
19	participate in civic life; and
20	MUEDEAG Oite managements and management to be according to the control of the con
21	WHEREAS, City governments are not required to take any actions that will result in a
22 23	fundamental alteration or in undue financial and administrative burdens. 28 C.F.R. §§ 35.160-35.164; and
23 24	55.104, and
25	WHEREAS, in early 2017, the City of Hallandale Beach commenced providing closed
26	captioning for official government meetings streamed online; and
27	
28	WHEREAS, the City has designated an ADA Coordinator for records and communication
29	purposes to individuals requiring accommodation; and
30	
31	WHEREAS, the City of Hallandale Beach, in accordance with the ADA and Florida law,
32	will provide reasonable accommodations to any person with a disability who needs an
33	accommodation in order to attend any City public hearing or meeting of a body, board, or
34	magistrate acting in its official capacity on behalf of the City with 48 hours notice in advance of
35	the scheduled public hearing or meeting; and

37	WHEREAS the City has revised and expanded ADA disclosures and notifications of

accommodations on the City's websites; and

39	WHEREAS, the City sought to provide public access to archived videos of governmental		
40	meetings, but has determined that closed captioning years of meetings is cost-prohibitive		
41	Therefore, the City has determined that all uncaptioned videos of meetings and other marketing		
42	videos will be removed from City websites, but can be provided with accommodation upon		
43	request; and		
44			
45	WHEREAS, staff has received training for making web content more accessible to		
46	accommodation software for the visually impaired and is in the process of implementing new		
47	software to expand accessibility to readers and other accommodations; and		
48			
49	WHEREAS, the Mayor and City Commission of the City of Hallandale Beach hereby		
50	establish a policy of ADA accessibility for the City's websites and digital communications to certify		
51	current and continued compliance with ADA accessibility.

53	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF		
54	THE CITY OF HALLANDALE BEACH, FLORIDA:

56	SECTION 1. The foregoing "Whereas" clauses verified as true and correct and are		
57	incorporated herein.		
58			
59	SECTION 2. The Mayor and City Commission hereby require the City Administration to		
60	maintain policies and practices to ensure the current and continued compliance of the City's digital		
61	content with ADA requirements and to maximize the accessibility of civic content for all users. City		
62	administration is directed to continually update and maintain the City's website to ensure that it		
63	remains fully accessible.

65	<b>SECTION 3. Effective Date.</b> This Resolution shall take effect immediately upon its		
66	passage and adoption.
