A RESOLUTION OF CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH **COMMUNITY** REDEVELOPMENT AGENCY. HALLANDALE BEACH. FLORIDA, APPROVING AN AWARD OF A COMMERCIAL FACADE IMPROVEMENT GRANT IN THE AMOUNT OF \$100,000, A COMMERCIAL INTERIOR RENOVATION GRANT IN THE AMOUNT OF \$90,000, A COMMERCIAL KITCHEN GRANT IN THE AMOUNT OF \$300,000 AND A TENANT LEASE SURETY/TENANT RENT SUBSIDY IN THE AMOUNT OF \$7.864 TO AARONSHOSH INVESTMENTS LLC FOR THE RENOVATION OF THE PROPERTY LOCATED AT 129 N.E. 1ST AVENUE, HALLANDALE BEACH, FLORIDA; **AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE** AGREEMENT: **AUTHORIZING** THE GRANT EXECUTIVE DIRECTOR TO TAKE ALL STEPS NECESSARY AND APPROPRIATE TO IMPLEMENT THE TERMS AND CONDITIONS OF THE GRANT AGREEMENT AND DISBURSE THE GRANTS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** the mission of the Hallandale Beach Community Redevelopment Agency ("HBCRA") is to promote economic development and enhance the quality of life by eliminating and preventing blighted conditions through the facilitation of community partnerships, business growth, job creation, and neighborhood rehabilitation; and

WHEREAS, on February 20, 2018, the Board of Directors of the HBCRA approved new Commercial Incentive Programs that include the Commercial Façade Improvement Grant Program, the Commercial Interior Renovation Grant Program, the Commercial Kitchen Grant Program, the Property Tax Reimbursement, the Tenant Lease Surety/Tenant Rent Subsidy, and the Commercial Business - Low Cost or No-Interest Loan; and

WHEREAS, the HBCRA has received an application from Aaronshosh Investments LLC requesting the following: a Commercial Façade Improvement Grant in the amount of \$100,000, a Commercial Interior Renovation Grant in the amount of \$90,000, a Commercial Kitchen Grant in the amount of \$300,000 and a Tenant Lease Surety/Tenant Rent Subsidy in the amount of \$7,864, all for the renovation of real property located at 129 NE 1st Avenue, Hallandale Beach, Florida; and

**WHEREAS**, the total project cost, which includes both hard and soft costs is estimated to be \$687,887; and

WHEREAS, the Board of Directors of the HBCRA desires to award to Aaronshosh Investments LLC a Commercial Façade Improvement Grant in the amount of \$100,000, a

The award of a Commercial Façade Improvement Grant in 47 the amount of \$100,000, a Commercial Interior Renovation Grant in the amount of \$75,000, a 48 Commercial Kitchen Grant in the amount of \$300,000 and a Tenant Lease Surety/Tenant Rent 49 Subsidy in the amount of \$7,864 to Aaronshosh Investments LLC is hereby approved. 50 Section 3. Negotiation and Execution of Grant Agreement. The Executive Director is hereby authorized to negotiate and execute a Grant Agreement with Aaronshosh Investments 51 LLC for a Commercial Facade Improvement Grant in the amount of \$100,000, a Commercial 52 53 Interior Renovation Grant in the amount of \$90,000, a Commercial Kitchen Grant in the amount 54 of \$300,000 and a Tenant Lease Surety/Tenant Rent Subsidy in the amount of \$7,864, which Grant Agreement will provide the terms and conditions by which the HBCRA will disburse the 55 56 Grants. Section 4. Implementation of Grant Agreement. The Executive Director is hereby 57 58 authorized to take all steps necessary and appropriate to implement the terms and conditions of 59 the Grant Agreement with Aaronshosh Investments LLC including disbursement of the Grants in 60 accordance with the Grant Agreement. 61 Section 5. Effective Date. This resolution shall take effect immediately upon approval.
