### Short Title:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, SUPPORTING THE BROWARD METROPOLITAN PLANNING ORGANIZATION'S (MPO) PROPOSED PROJECTS FOR THE CITY OF HALLANDALE BEACH IN COMMITMENT FOR THE 2045 METROPOLITAN TRANSPORTATION PLAN (MTP); FURTHER WORKING WITH THE BROWARD MPO, ITS TRANSPORTATION PARTNERS, AND THE PUBLIC TO PREPARE ALL THE PROJECTS FOR PROGRAMMING

#### IN THE BROWARD MPO'S TRANSPORTATION IMPROVEMENT PROGRAM; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS TO SUBMIT APPLICATIONS AND IMPLEMENT THE PROJECT WITH THE BROWARD MPO; AND PROVIDING FOR AN EFFECTIVE DATE.

#### Staff Summary:

### Summary:

The proposed Resolution supports all the Broward MPO (Metropolitan Planning Organization) proposed projects committed in the MPO's 2045 MTP (Metropolitan Transportation Plan) for the City of Hallandale Beach, except for a portion of the Hallandale Beach bypass project. The Resolution further supports and provides the necessary authorizations for the City's continued coordination with MPO, its partners and the public in the preparation and implementation of the schedule of projects from the Transportation Improvement Program.

### Background:

The Broward Metropolitan Planning Organization (Broward MPO or MPO) is a federallymandated agency that is responsible for making policy on local transportation issues and deciding how to spend federal money on transportation projects within Broward County. The Broward MPO kicked off development of its Metropolitan Transportation Plan, Commitment 2045 in 2018. The plan allocates available funding to maintain and improve Broward's transportation system now and in the future. Working with the cities, it serves as the basis for identifying priorities and transportation projects that will be implemented in the coming years and through 2045.

At the April 4, 2018 City Commission meeting, staff brought forward a list of proposed transportation projects for discussion in response to the Broward MPO's MTP call for projects. The City Commission supported a response to the MPO's call for projects with a list of proposed transportation projects. The original list included 6 transportation projects, 5 of those projects where deemed eligible for the MPT by the MPO. The projects included in the MPO's draft MTP are listed below.

Staff does not agree with that portion of the project described as "an express left turn bypass on westbound Hallandale Beach Blvd to southbound US-1;" because it is inconsistent with the urban environment envisioned by the City's Master Plan.

# Why Action is Necessary:

Federal law requires the Broward MPO (and MPO's across the country) to update their Metropolitan Transportation Plan every five years. Commitment 2040, the previous MTP, was adopted by the MPO Board in December 2014. Work on Commitment 2045, the update of Commitment 2040, began in December 2017 and will be complete in 2019 with adoption of the final plan by the Broward MPO. Projects included as part of Commitment 2045 can be completed in as little as six years, depending on funding availability.

The Broward MPO is requiring all projects identified in the draft Commitment 2045 MTP as "cost feasible" have a local resolution of support to remain in the final MTP. Projects without a resolution by August 1, 2019 will be removed from the MTP and/or placed in the "needs and unfunded" portion of the MTP.

## **Proposed Action:**

Staff recommends the Mayor and City Commission adopt the resolution by which the City supports all the Broward Metropolitan Planning Organization's (MPO) proposed projects for the City of Hallandale Beach in Commitment 2045 Metropolitan Transportation Plan (MTP) except that portion of the Hallandale Beach Boulevard Bypass project described as "an express left turn bypass on westbound Hallandale Beach Blvd to southbound US-1;" further working with the Broward MPO, transportation partners, and the public to prepare all the projects for programming in the Broward MPO's Transportation Improvement Program; and authorizing the City Manager to execute all necessary documents to submit applications and implement the project with the Broward MPO.
