4 A RESOLUTION OF THE MAYOR AND CITY
5 COMMISSION OF THE CITY OF HALLANDALE BEACH,
6 FLORIDA, AUTHORIZING THE CITY MANAGER TO
7 APPROVE THE PURCHASE OF TWO SOLID WASTE
8 COLLECTION TRUCKS UTILIZING THE FLORIDA
9 SHERIFFS ASSOCIATION & FLORIDA ASSOCIATION OF
10 COUNTIES CONTRACT (FSA18-VEH16.0) WITH CAB &
11 CHASSIS TRUCKS & HEAVY EQUIPMENT IN THE NOT
12 TO EXCEED AMOUNT OF SIX HUNDRED TWELVE
13 THOUSAND NINE HUNDRED AND SEVENTY-EIGHT
14 DOLLARS (\$612,978); AUTHORIZING THE CITY
15 MANAGER TO EXECUTE ALL RELATED DOCUMENTS
16 TO EFFECTUATE THE PURCHASE FOR THE 2018/2019
17 FISCAL YEAR; AND PROVIDING AN EFFECTIVE DATE.

19 **WHEREAS**, during Fiscal Year 2018-2019 budget, the City Commission approved
20 the budgeted amount of Six Hundred Twelve Thousand Nine Hundred and Seventy-Eight
21 dollars (\$612,978) for the purchase of the Two (2) New Solid Waste Collection Trucks;
22 and

23 **WHEREAS**, pursuant to Chapter 23, Section 23-8, Exception to Bid Requirements
24 (6), Bids and Contracts from Other entities, and Section 23-9 Cooperative Purchasing, the
25 City Manager is authorized to procure all supplies, materials, equipment, and services
26 from other governmental units, when the best interests of the City would be served, subject
27 to the requirement that any purchase in excess of \$50,000 requires City Commission
28 approval; and

30 **WHEREAS**, the residential solid waste collection operation currently operates six
31 (6) full size garbage trucks and while replacement of these vehicles would have been
32 2023, there have been frequent breakdowns, high maintenance costs and the
33 replacement of these trucks with diesel operated trucks will eliminate the travel time for
34 fueling which will increase efficiency; and

36 **WHEREAS**, The Florida Sheriffs Association & Florida Association of Counties
37 has awarded a contract to Cab & Chassis Trucks & Heavy Equipment; and

WHEREAS, Cab & Chassis Trucks & Heavy Equipment has issued to The City of Hallandale Beach a Piggyback Authorization Letter as attached as Exhibit 3; and

WHEREAS, the City Manager recommends the approval of the purchase of two (2) solid waste collection trucks, as in the best interest of the City of Hallandale Beach and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. City Manager Authorization. The Mayor and City Commission hereby authorize the City Manager to execute an agreement to purchase (2) Two New Solid Waste Collection Trucks from Cab & Chassis Trucks & Heavy Equipment in substantially the same form as the Florida Sheriffs Association & Florida Association of Counties FSA18-VEH16.0 awarded contract with Cab & Chassis Trucks & Heavy Equipment for an amount not to exceed SIX HUNDRED TWELVE THOUSAND NINE HUNDRED AND SEVENTY-EIGHT DOLLARS (\$612,978).

SECTION 2. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
