Short Title:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER TO EXECUTE A RENEWAL OF THE INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR THE USE OF THE COUNTY'S OPTIONAL SERVICE OF THE BULK TRASH AND YARD WASTE DROPOFF PROGRAM UNTIL SEPTEMBER 30, 2020; AUTHORIZING THE CITY MANAGER TO TAKE ALL NECESSARY ACTIONS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE INTERLOCAL AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

S	taff Summary:

Summary:

The City of Hallandale Beach (City) is seeking to renew the existing "Interlocal Agreement for Optional Services (ILA) Bulk Trash and Yard Waste Drop-Off Program" with Broward County (County). This agreement allows residents to drop-off Bulk Trash and Yard Waste at permanent locations.

Background:

On August 28, 2012, the Board of County Commissioners approved the formation of an Interlocal agreement to allow municipalities in Broward County to use County services for Keep Broward Beautiful, Household Hazardous Waste, Bulk Trash and Yard Waste programs on a fee-for-service basis (Exhibit 3). The agreement expired September 30, 2018.

The City of Hallandale Beach decided to enter in this ILA three (3) months prior to the expiration of this agreement. The City opted to participate in the Bulk Trash and Yard Waste Drop-Off Program, which provides service to resident customers at permanent drop-off locations. (Exhibit 2). Simultaneously, the County processed the first amendment of the agreement with the City to extend the ILA until September 30, 2019 (Exhibit 3).

Current Situation:

On June 11, 2019, Hallandale Beach received correspondence from the Broward County Board of County Commissioners proposing to renew the ILA until September 30, 2020. This ILA may be extended for up to four additional one-year terms. In order to allow for budgetary planning, the County has requested that the City execute the ILA and return, in order to participate in the Agreements programs (Exhibit 4).

Fiscal Impact:

The fiscal impact of this service is based upon fee-for-service.

Why Action is Necessary:

Pursuant to the terms of the Interlocal Agreement for Optional County Service, the City of Hallandale Beach Code of Ordinances, the City Manager shall have the authority to recommend to the City Commission award of contracts.

Proposed Action:

Staff recommends approval of the attached Resolution authorizing the City Manager to extend the Interlocal Agreement by and between Broward County and the City of Hallandale Beach for

the use of the County's Optional Service of the Bulk Trash and Yard Waste Drop-Off program until September 30, 2020, with the option to extend the ILA for up to four additional one-year terms.
