12	WHEREAS, on March 1, 2017, the City Commission awarded RFP #FY 2015-
13	2016-24, Development of a Sustainability Action Plan, to Reynolds, Smith and Hills, Inc.
14	(RS&H) in an amount not to exceed \$70,000; and
15	
16	WHEREAS, the primary objective of the SAP is to provide a 5-year blueprint that
17	tangibly and measurably advances sustainability in the City. The SAP outlines a series of
18	projects to be implemented over a 5-year span, with benefits of these projects realized
19	over a period of 10 years and beyond; and
20	
21	WHEREAS, the City received the first draft of the SAP on February 23, 2018 and
22	City Administration provided comments and edits to RS&H and
23	
24	WHEREAS, the SAP includes a vision statement, goals, objectives,
25	policies/projects and an implementation plan. Final deliverables for the project include 1)
26	a comprehensive 5-year Sustainability Action Plan, 2) an executive summary condensing
27	the information in the SAP, 3) a concise public information document that will serve to
28	convey the information included in the SAP in an easy to understand manner, and 4)
29	design and content assistance for web-based material conveying the information
30	contained in the three preceding deliverables; and

32	WHEREAS, the SAP includes input from the SAP interdepartmental project team
33	and input through community workshops, a collaborative effort led and facilitated by the
34	Green Initiatives Coordinator; and

36	WHEREAS, individual projects contained in the plan will be budgeted and
37	procured in accordance with our general policies; and

39	WHEREAS, the Mayor and City Commission find that it is appropriate and in the
40	best interest of the City to approve and adopt the SAP.
41	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
42	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
43	<b>SECTION 1.</b> The foregoing "Whereas" clauses are incorporated herein.
44	SECTION 2. The Mayor and City Commission hereby accept the Sustainability
45	Action Plan. The City Manager is authorized to proceed with implementation of the plan.
46	SECTION 3. Effective Date. This Resolution shall take effect immediately upon
47	its passage and adoption.
