9 10	(\$249,056) DOLLARS ON TEMPORARY BUILDING PLAN REVIEW AND INSPECTION SERVICES FROM CALVIN,
11	GIORDANO & ASSOCIATES, INC. ; AND PROVIDING FOR AN
12	EFFECTIVE DATE.

14	WHEREAS, pursuant to Section 23-8(6) Bids and Contracts from other entities, the
15	City Manager is authorized to procure all supplies, materials, equipment and services
16	pursuant to competitive bids and formal contracts of other governmental units when the best
17	interests of the City would be served, subject to the requirement that any purchase in excess
18	of \$50,000.00 requires City Commission approval; and
19	
20	WHEREAS, The City Manager is authorized through No. 2018-063, to procure
21	inspection and building plan review services on an as needed basis from Calvin, Giordano $\&$
22	Associates, Inc., C.A.P. Government, Inc. and Bureau Veritas, in an amount not to exceed
23	the Building Division budgeted \$623,225; and
24	
25	WHEREAS, the Building Division utilized these services to fill several key positions,
26	including the Building Official position, which was vacant for several months in the beginning
27	of FY 18/19, nearly exhausting the P.O. capacity with paid expenses amounting to \$567,560.
28	Staffing services for the last quarter of FY 2018-19 are estimated at approximately \$234,000,
29	of which, \$55,665 are already encumbered for the services. Staff is seeking an increase of
30	\$180,000 to cover the remaining expenses; and
31	
32	WHEREAS, The Building Division functions under its own Special fund, which has
33	funding available and does not affect the General Fund; and
34	
35	WHEREAS, the City Commission concludes that it is in the best interest of the City of
36	Hallandale Beach to increase purchase order 2019-0757-00 to procure inspection and plan

37	review services to a new total amount not to exceed eight hundred and three thousand two
38	hundred and twenty five (\$803,225.) dollars for the remainder of fiscal year 2018-2019.

40	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION
41	OF THE CITY OF HALLANDALE BEACH, FLORIDA:
42	SECTION 1. The foregoing "Whereas" clauses are incorporated herein.
43	
44	SECTION 2. City Manager Authorization. City Manager is hereby authorized to
45	expend a total not to exceed eight hundred and three thousand two hundred and twenty five
46	(\$803,225.) dollars for temporary building plan review and inspection services from Calvin,
47	Giordano & Associates, Inc, for FY 18-19.

49	SECTION 3 . Effective Date . This resolution shall be effective immediately upon its
50	adoption.
