**WHEREAS**, the City Administration has identified a need to utilize the contracts to purchase Information Technology hardware, software, maintenance, along with maintenance and software licenses for the FY 2019-2020; and

WHEREAS, the US Communities Government Purchasing Alliance is a national organization co-founded and operated by a coalition of public organizations including the National League of Cities, The US Conference of Mayors (USCM), the National Association of Counties (NACO), the Association of School Business Officials and the National Institute of Government Purchasing (NIGP); and
