18	WHEREAS, pursuant to Section 23-9 of the City of Hallandale Beach ("City")
19	Code, the City Manager shall have the authority to join with other units of government in
20	cooperative purchasing plans or to purchase pursuant to formal written contracts or
21	competitive bids of other governmental units, when the best interests of the City would be
22	served, subject to the requirement that purchases in excess of \$50,000 require City
23	Commission approval; and

25	WHEREAS, the City administration seeks authorization for expenditures not to
26	exceed eighty-three thousand dollars (\$83,000) for custodial supplies from Supply Works
27	utilizing U.S. Communities Contract RFP # 17-21; and
28	
29	WHEREAS, authorized City staff received a log in to utilize the Supply Works
30	contracted pricing and make purchases on-line. Some of the purchases made by City staff
31	are paper towels, facial tissues, wipers, dispensing equipment, seat covers, brooms and
32	dust pans, can liners, restroom cleaners, and other related items on-line.
33	
34	WHEREAS, the Mayor and City Commission find that it is in the best interest of
35	the City of Hallandale Beach to authorize the utilization of the requested contract.

37	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY

45	three thousand dollars (\$83,000) as provided for in fiscal year 2019-2020 budget and
46	authorize the City Manager to execute all related documents to effectuate the purchase.
