**A RESOLUTION OF THE MAYOR AND CITY COMMISSION
OF THE CITY OF HALLANDALE BEACH, FLORIDA
DECLARING UNIQUE CIRCUMSTANCES AND
AUTHORIZING A MONTH TO MONTH AGREEMENT AS
NEEDED FOR UP TO SIX MONTHS UNDER PROVISIONS OF
THE EXISTING CONTRACT WITH LIMOUSINES OF SOUTH
FLORIDA, INC., RFP # FY2013-2014-002; FURTHER
AUTHORIZING THE CITY MANAGER TO EXECUTE ANY
AGREEMENTS AND RELATED DOCUMENTS TO
EFFECTUATE THE PROJECT; AND PROVIDING FOR AN
EFFECTIVE DATE.**

WHEREAS, pursuant to Section 23-6, Award of Contracts, and 23-8, Unique Circumstances, the City Commission may declare unique circumstances as an exception to the requirements of competitive bidding; and

WHEREAS, the City began offering the community transportation service over fifteen years ago. The Community Bus System is a free service provided to residents and visitors of Hallandale Beach, consisting of 4 routes with 5 buses; and

WHEREAS, on May 21, 2014 the City Commission approved via Resolution 2014-45 the Agreement for Community Bus Services with Limousines of South Florida, Inc., RFP #2013-2014-002, and awarded them the responsible, responsive bidder; and

WHEREAS, the current contract is set to expire on September 30, 2019 and a current Request for Proposals is out for a new contract for service. This service is funded by various sources including the City's Transportation Fund, the City's Community Redevelopment Agency and a Broward County Grant; and

WHEREAS, The City's ILA with Broward County is also set to expire in September. City administration is concerned that the lack of secured agreements for funding may delay the award of a new contract because the RFP requests a significant capital investment by potential proposers; and

WHEREAS, the City administration recommends that the Agreement for Community Bus System, RFP # FY2013-2014-002, be extended and continue on a month to month basis, as needed, for up to six months under the current contract with Limousines of South Florida, Inc. to allow for staff to finalize the current solicitation being advertised and to avoid any potential interruptions of service.

47 **SECTION 1. City Manager Authorization.** The Mayor and City Commission hereby
48 authorize the extension of the Agreement for Community Bus System, RFP # FY2013-2014-
49 002, to continue on a month-to-month basis for up to six months under the current contract
50 with Limousines of South Florida, Inc. to allow for staff to finalize the current solicitation being
51 advertised and authorize the City Manager to execute any amendments to the Interlocal
52 Agreement and related documents to effectuate the project.

54 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its
55 passage and adoption.

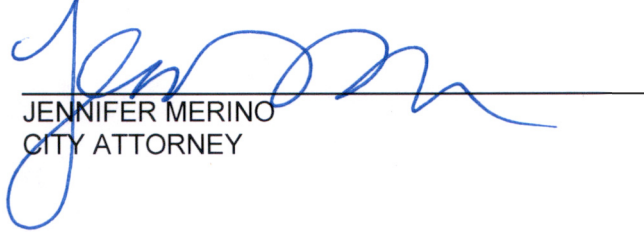
