Ad Hoc Members are appointed on a needs only basis to serve as subject matter experts and/or to help address specialized situations.

Ms. Daise also served as the facilitator for the Community Partnership Grant Review Committee meeting and provided an overview of the Martin Luther King Jr. Humanitarian Award Application process. Ms. Daise provided members with the MLK Nomination Packets including the following documents:
