4 A RESOLUTION OF THE MAYOR AND CITY  
5 COMMISSION OF THE CITY OF HALLANDALE BEACH,  
6 FLORIDA, AUTHORIZING THE USE OF CITY OF WEST  
7 PALM BEACH CONTRACT #19629 FOR SCHOOL  
8 CROSSING GUARD SERVICES FROM ACTION LABOR  
9 MANAGEMENT, LLC FOR AN AMOUNT NOT TO  
10 EXCEED SIXTY TWO THOUSAND (\$62,000.00)  
11 DOLLARS; AUTHORIZING THE CITY MANAGER TO  
12 EXECUTE THE CONTRACT AND ALL RELATED  
13 DOCUMENTS TO EFFECUATE THE PURCHASE; AND  
14 PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, pursuant to Section 23-8(6) Bids and Contracts from other  
18 entities, the City Manager is authorized to procure all supplies, materials, equipment and  
19 services pursuant to competitive bids and formal contracts of other governmental units  
20 when the best interests of the City would be served, subject to the requirement that any  
21 purchase in excess of \$50,000.00 requires City Commission approval; and

23 **WHEREAS**, Hallandale Beach is home to many students who rely on walking as  
24 their primary method of commuting to and from school. There are both primary and  
25 secondary schools in the City and adjoining our City limits on Pembroke Road is the  
26 McNichol Middle School; and

28 **WHEREAS**, children often must traverse busy streets like Hallandale Beach  
29 Boulevard and Pembroke Road on their way to and from school; and  
30

31 **WHEREAS**, providing crossing guard services is a necessary and prudent service  
32 to help ensure the public safety of children; and  
33

34 **WHEREAS**, the City Administration recommends that the City piggyback the City  
35 of West Palm Beach and Action Labor of Florida, LLC contract #19629 for school crossing  
36 guard services in the amount not to exceed sixty-two thousand (\$62,000.00) dollars as  
37 provided for in fiscal year 2019 - 2020 budget. This contract was awarded as a result of a  
38 City Invitation for Bid process released by the City of West Palm Beach; and

40           **WHEREAS**, Action Labor of Florida, LLC will provide six (6) guards and one (1)  
41 supervisor to provide enhanced pedestrian safety in the school zones at a reduced hourly  
42 rate of \$12.60. These crossing guards will be stationed at 8<sup>th</sup> Avenue on West Hallandale  
43 Beach Boulevard and on designated street corners surrounding the newly consolidated  
44 Gulfstream Academy of Hallandale Beach campus. There will also be a crossing guard  
45 on Pembroke Road for McNichol students.

47           **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**  
48 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

49           **SECTION 1. City Manager's Authorization.** The Mayor and City Commission  
50 hereby authorize the City Manager to utilize the City of West Palm Beach and Action Labor  
51 of Florida, LLC contract #19629 for school crossing guard services in the amount not to  
52 exceed sixty-two thousand (\$62,000.00) dollars for fiscal year 2019-2020. The City  
53 Manager is authorized to execute the contract and all related documents necessary to  
54 effectuate the purchase.

56           **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon  
57 its passage and adoption.
