RESOLUTION NO. 2020 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED BID #FY2017-2018-014-001, UNIFORM PURCHASE FOR THE HALLANDALE POLICE DEPARTMENT, TO THE LOWEST BIDDER, LOU'S POLICE DISTRIBUTORS, INC. IN THE AMOUNT NOT TO EXCEED FIFTY TWO THOUSAND DOLLARS (\$52,000) ANNUALLY FOR A TOTAL COSTS NO TO EXCEED FIFTY TWO THOUSAND DOLLARS (\$52,000) FOR A FIVE (5) YEAR TERM; AND PROVIDING AN EFFECTIVE DATE .

WHEREAS, the City released bid solicitation and award in November 2019 for uniform purchase contract for the Hallandale Beach Police Department for two (2) types of Police uniforms; and

WHEREAS, the City received two submitted bids from vendors Lou's Police Distributors, Inc. and Gold Nugget Uniform, Inc. dba Argo Uniform; and

WHEREAS, staff has reviewed the two (2) bids and recommends award to the lowest responsive, responsible bidder; and

WHEREAS, the City Administration further urges the City Commission to award the Police Uniform bid# FY 2017-2018-014-001 to the lowest bidder, Lou's Police Distributors, Inc. The award is not to exceed fifty-two thousand dollars (\$52,000) annually, for a term of five (5) years.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. City Commission Action. The Mayor and City Commission hereby award Bid #2017-2018-014-001, for Hallandale Police Department uniform purchase to Lou's Police Distributors, Inc. as the lowest responsive, responsible bidder

SECTION 2. City Manager Authorization. The Mayor and City Commission hereby authorize the City Manager to execute all related documents to effectuate the

37 purchase with Lou's Police Distributors, Inc. in an amount not to exceed fifty-two thousand
38 (\$52,000) dollars annually, for a five (5) year contract term.
