CHANGE FROM:

6. Frequency of Service

- a. Proposed passengers should have waiting intervals of no more than sixty-five (65) minutes during hours of operation. This is subject to change at the City's discretion.
- b. Service will be provided at a minimum level of six (6) days per week for COHB Community Shuttle Services Routes 1, 2 and 3; and 7 days for COHB Community Shuttle Service Route 4; with a minimum of 120 hours for COHB Community Shuttle Services Routes 1, 2 and 3; and 144 hours for COHB Community Shuttle Services Route 4.

CHANGE TO:

6. Frequency of Service

- c. Proposed passengers should have waiting intervals of no more than sixty-five (65) minutes during hours of operation. This is subject to change at the City's discretion.
- d. Service will be provided at a minimum level of six (6) days per week for COHB Community Shuttle Services Routes 1, 2 and 3; and 7 days for COHB Community Shuttle Service Route 4; with a minimum of sixty-six (66) hours for COHB Community Shuttle Services Routes 1, 2 and 3; and seventy-eight (78) hours for COHB Community Shuttle Services Routes 1, 2 and 3; and seventy-eight (78) hours for COHB Community Shuttle Services Route 4.
