SHORT TITLE:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPOINTING COMMISSION MEMBERS AS CITY REPRESENTATIVES TO THE BROWARD LEAGUE OF CITIES, FLORIDA LEAGUE OF CITIES, AND THE NATIONAL LEAGUE OF CITIES FOR THE 2020-2021 TERM; AND PROVIDING AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

The National League of Cities, Florida League of Cities and Broward League of Cities are organizations, composed of elected officials, that advocate local priorities at the national (federal),

state, and local levels, respectively. In addition, the organizations serve as a forum for exchange of best practices and representation of the City of Hallandale Beach's interests.

Annually, the City Commission appoints Directors, Voting Delegates, and/or Alternates to represent the City of Hallandale Beach on the Broward League of Cities, Florida League of Cities, and National League of Cities Board of Directors. These representatives serve on an annual basis.

Background:

Based on the November 6, 2018, General and Special Election and change in composition of the City's elected body, the City Commission reconsidered its prior appointments of the voting delegates for the Broward League of Cities, Florida League of Cities and National League of Cities for the for the 2019-2020 term.

As a result, on January 9, 2019, the City Commission adopted Resolution 2019-005 (Exhibit 2) designating the following voting members for the remainder of the year to represent the City:

Broward League of Cities

Director – Commissioner Anabelle Lima-Taub
1st Alternate – Vice Mayor Sabrina Javellana
2nd Alternate – Mayor Joy D. Adams (*Former*)

Florida League of Cities

Voting Delegate – Vice Mayor Sabrina Javellana
Alternate – Commissioner Mike Butler

National League of Cities

Voting Delegate – Vice Mayor Sabrina Javellana
1st Alternate – Commissioner Anabelle Lima-Taub

Appointments made by the City Commission through Resolution 2019-005 were in effect for one year/remainder of the 2019-2021 term.

Current Situation:

Any appointments made by the City Commission through the attached proposed Resolution (Exhibit 1) will take effect immediately for one year.

Below are the dates for upcoming events/conferences:

- Broward League of Cities: 63rd Annual Gala – *Postponed* – New Date To Be Announced.
- Florida League of Cities Annual Conference: August 13-15, 2020, Diplomat Beach Resort, Hollywood, Florida.
- National League of Cities City Summit: November 18 – 21, 2020, Tampa, Florida.

Why Action is Necessary:

Pursuant to the Broward League of Cities' By-Laws, each City shall appoint a Director, Alternate, and Second Alternate to attend and vote at any Board of Directors or General Membership Meeting held where he/she represents his/her City.

Pursuant to the Florida League of Cities' By-Laws, each municipality shall appoint a Voting Delegate and an Alternate to attend and vote at the Annual Business Session.

Pursuant to the National League of Cities' By-Laws, each municipality shall appoint a Voting Delegate and up to two Alternates (if desired) to attend and vote at the Annual Business Meeting.

Pursuant to Article V, Section 5.01 of the City of Hallandale Beach Charter, a Resolution adopted by the Commission is an expression of the Commission on a provision for the disposition of a particular item of the administrative business of the governing body

Cost Benefit:

Although there is no fiscal impact other than the payment of dues and travel to meetings as necessary; appointments to the Broward, Florida and National League of Cities will ensure advocacy of local priorities and the Cities best interests are represented at the local, state and national (federal) levels.

PROPOSED ACTION:

Staff recommends the City Commission consider the appointments of Directors, Voting Delegates, and/or Alternates to represent the City of Hallandale Beach on the Broward League of Cities, Florida League of Cities, and National League of Cities Board of Directors.
