14	WHEREAS, degasifier packing media helps reduce and remove unwanted elements	
15	and gases in pre-treated water, removing particles of metals such as iron and manganese	
16	and gases such as carbon dioxide, methane and hydrogen sulfide, and allows volatile	
17	substances such as phenol, to escape or vaporize from City drinking water; and	
18		
19	WHEREAS, the City's water treatment plant's two degasifier towers have been	
20	working in an alternating mode since they were first commissioned back in 2008 and are past	
21	their useful life of eight to ten years; and	
22		
23	WHEREAS the proposed removal and replacement of the degasifier packing media	
24	will closely follow the replacement of the nanofiltration membrane authorized by Resolution	
25	2019-077 in order to have a comprehensive recommissioning of the water filtration system at	
26	the water plant; and	
27		
28	WHEREAS, on August 15, 2019, RE-BID FY 2018-2019-008-001 solicited bids for the	
29	replacement of the degasifier packing media. TLC Diversified, Inc. and Lawrence Lee	
30	Construction were the only two bidders. TLC was the lowest responsible bidder for the	
31	removal and replacement for an amount not to exceed one hundred thirty-eight thousand two	
32	hundred and fifty dollars (\$138,250); and	
33		
34	WHEREAS, the Mayor and City Commission find that contracting with TLC Diversified,	
35	Inc. for the removal and replacement the degasifier pack media is in the public interest.

37	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY		
38	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

40	SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

42	SECTION 2. The Mayor and City Commission hereby award Re-Bid # FY 2018-		
43	2019-008-001 to TLC Diversified, Inc., in an amount not to exceed one hundred thirty-eight		
44	thousand two hundred and fifty dollars (\$138,250) for removal and replacement of degasifier		
45	packing media and authorize the City Manager to negotiate and execute the necessary		
46	agreements to effectuate the award.

49	passage and adoption.
