10	WHEREAS, the City Community Shuttle Service is a free service provided to		
11	residents and visitors of Hallandale Beach for over twenty (20) years; and

13	WHEREAS, on February 19, 2020, the City Commission voted to award RFP #		
14	FY2018-2019-007 for Minibus Services to LIMOUSINES OF SOUTH FLORIDA INC. and		
15	authorized the City Manager to negotiate a contract that will be brought back for Ci		
16	Commission approval; and

18	WHEREAS, in March of 2020, the City declared a state of emergency due to the		
19	global pandemic of COVID-19. Events related to the pandemic drastically affected global		
20	businesses and economies. Rapidly shifting dynamics resulted in an inability for the		
21	awarded minibus shuttle Contractor for RFP FY 2018-2019-007 to reach an agreement t		
22	proceed with the award as solicited by the City and as proposed by the Contractor; and		
23			
24	WHEREAS, Section 23-12 of the City's Code permits the City Commission to		
25	authorize the City Manager to reject all bids and re-advertise a new solicitation; and		
26			
27	WHEREAS, City Administration has identified an alternative option for providing		
28	the services and recommends that the solicitation be reissued for operation and		
29	maintenance of the minibus service with propane buses to be obtained by City from		
30	County, and a future transition into an all-electric vehicle fleet.; and		
31			
32	WHEREAS, the Mayor and City Commission find it is in the best interests of the		
33	residents of the City to reject all proposals and issue a new solicitation based on the City's		
34	current needs and situation.
