RESOLUTION NO. 2020-

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO REJECT ALL PROPOSALS FOR RFP # FY2018-2019-007 MINIBUS SERVICES; RESCINDING AWARD TO LIMOUSINES OF SOUTH FLORIDA INC.; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Community Shuttle Service is a free service provided to residents and visitors of Hallandale Beach for over twenty (20) years; and

WHEREAS, on February 19, 2020, the City Commission voted to award RFP # FY2018-2019-007 for Minibus Services to LIMOUSINES OF SOUTH FLORIDA INC. and authorized the City Manager to negotiate a contract that will be brought back for City Commission approval; and

WHEREAS, in March of 2020, the City declared a state of emergency due to the global pandemic of COVID-19. Events related to the pandemic drastically affected globally businesses and economies. Rapidly shifting dynamics resulted in an inability for the awarded minibuss shuttle Contractor for RFP FY 2018-2019-007 to reach an agreement to proceed with the award as solicited by the City and as proposed by the Contractor; and

WHEREAS, Section 23-12 of the City's Code permits the City Commission to authorize the City Manager to reject all bids and re-advertise a new solicitation; and

WHEREAS, City Administration has identified an alternative option for providing the services and recommends that the solicitation be reissued for operation and maintenance of the minibuss service with propane buses to be obtained by City from County, and a future transition into an all-electric vehicle fleet.; and

WHEREAS, the Mayor and City Commission find it is in the best interests of the residents of the City to reject all proposals and issue a new solicitation based on the City's current needs and situation.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing “Whereas” clauses are incorporated herein.

SECTION 2. The Mayor and City Commission hereby rescind and repeal the award contract for Minibus Services to LIMOUSINES OF SOUTH FLORIDA INC, authorize the City Manager to reject all proposals received pursuant to RFP FY 2018-2019-007 and to issue a new solicitation for Minibus Services.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
