# SHORT TITLE:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, APPROVING THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF HALLANDALE BEACH AND BROWARD COUNTY IN MATTERS RELATING TO COVID-19 CODE ENFORCEMENT ACTIVITIES; AND PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

# **STAFF SUMMARY:**

#### Summary:

Broward County seeks the City's assistance with enforcement of COVID-19 Emergency Orders and will provide the City a flat payment of \$9,400 per month for seven months.

#### Background:

Section 8-56 of the Broward County Code of Ordinances provides for penalties of up to One Thousand Dollars (\$1,000) per day, up to Fifteen Thousand Dollars (\$15,000) per violation, pursuant to the code enforcement processes of the City.

#### Current Situation:

Under the terms of the agreement Broward County provides a monthly payment to the City in the amount of \$9,400 totaling no more than \$65,800 for the 7-month enforcement period. The County is utilizing a portion of its CARES Act funding for "enforcement by local governments of public health orders related to COVID-19'. (Exhibit 3). The amount of funding provided to the cities is on a per capita basis assuming and a County-wide average enforcement cost and a projected number of complaints.

The enforcement period is June 1, 2020 through December 31, 2020.

The City is responding to complaints received by Broward County. Pursuant to the agreement, the City will log the outcome of the complaint into the County's 311 system.

#### Why Action is Necessary

Interlocal Agreements may be entered into by the City Commission pursuant to Section 163.01, Florida Statutes, also known as the "Florida Interlocal Cooperation Act of 1969.

#### Cost Benefit:

This unbudgeted revenue will be used to cover the related expenses.

### **PROPOSED ACTION:**

City Commission to authorize the City Manager to enter into the Interlocal Agreement.
