WHEREAS, at a duly noticed meeting held on October 21, 2019, the Board of Directors of the HBCRA adopted Resolution No. 2019 - 039 pursuant to which the Board of Directors of the HBCRA approved an Agreement with Upscale Events by Mosaic LLC d/b/a The Mosaic Group, LLC ("Mosaic") to provide marketing services in an amount not to exceed \$50,000; and

WHEREAS, at a duly noticed meeting held on February 10, 2020, the Board of Directors of the HBCRA approved a Change Order to the Agreement, providing an additional \$30,000 to Mosaic for marketing purchases in connection with the HBCRA strategic marketing plan; and

WHEREAS, HBCRA Staff recommends that the Board of Directors of the HBCRA approve a second Change Order to the Agreement, providing an additional \$30,000 to Mosaic to expand the scope of services and include a new scope of services that incudes the relief efforts to support the local business due to the impacts of COVID-19 with a total Agreement amount not to exceed \$110,000; and

WHEREAS, the Board of Directors of the HBCRA desires to approve a second Change Order to Mosaic's existing Agreement, providing an additional \$30,000 to Mosaic to expand the scope of services and include a new scope of services that incudes the relief efforts to support the local business due to the impacts of COVID-19 with a total Agreement amount not to exceed \$110,000.
