3 4 5 6 7	A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, SUPPORTING THE UPDATE TO THE UNIFIED SEA LEVEL RISE PROJECTION OF SOUTHEAST FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

9	WHEREAS, the Southeast Florida Regional Climate Change Compact ("the Compact")
10	Steering Committee first convened a Technical Ad Hoc Work Group to develop a unified sea
11	level rise projection for the Southeast Florida region in 2010; and
12	
13	WHEREAS, in September 2014, the Work Group was reconvened for the purpose of
14	updating the Compact's Sea Level Rise projection based on projections and scientific literature
15	released since 2011; and
16	
17	WHEREAS, the Work Group recommended review and update of the projection
18	following the release of the Fifth Assessment Report by the United Nations Intergovernmental
19	Panel on Climate Change ("IPCC"); and
20	
21	WHEREAS, the 2015 update to the Regional Sea Level Rise Projection incorporates the
22	IPCC curve as the lower boundary and the U.S. Army Corps of Engineer's curve as the upper
23	boundary, which are considered appropriate guidance for the majority of land use and
24	infrastructure planning decisions and investments by the region; and
25	
26	WHEREAS, based on these curves, sea level rise is projected to be six (6) to ten (10)
27	inches by 2030 and fourteen (14) to twenty six (26) inches by 2060; and
28	
29	WHEREAS, the near term planning horizons (through 2060) are critical to
30	implementation of the Southeast Florida Regional Climate Change Action Plan and Broward's
31	Community-wide Climate Change Action Plan and efforts to optimize the remaining economic
32	life of existing infrastructure while advancing adaptation strategies; and
33	
34	WHEREAS, the Mayor and City Commission have determined that the residents and
35	public should support the 2015 update to the United Regional Sea Level Rise Projection for 1 RESO. NO. 2016 -

36	Southeast Florida as the basis for sea level rise adaptation planning in Hallandale Beach and
37	across Broward County.

39	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION
40	OF THE CITY OF HALLANDALE BEACH, FLORIDA:
41 42	SECTION 1. Supporting the 2015 Update to the Unified Regional Sea Level Rise
43	Projection . The Mayor and City Commission of the City of Hallandale Beach support the 2015
44 45	update to the Unified Regional Sea Level Rise Projection for Southeast Florida.
46	SECTION 2. Directions to City Clerk. The Mayor and City Commission direct the
47	City Clerk to cause a copy of this resolution to be forwarded to all appropriate parties.
