L7	WHEREAS, the City of Hallandale Beach (the "City"), its Mayor and City										
L8	Commission, publicly denounce human trafficking and forced labor known to be a horrific										
L9	assault on human dignity and condemn this form of human rights violation via persecution

22	WHEREAS, the phrase "Never again" is associated with the Holocaust and other										
23	genocides, and should also be coined when addressing the gross violations of human										
24	rights in Xinjiang Uyghur Autonomous Region; and

26	WHEREAS, the City actively promotes the acceptance of every race, ethnicity and										
27	religion; and

29	WHEREAS, in the Xinjiang Uyghur Autonomous Region, the Government of the										
30	People's Republic of China has established a system of extrajudicial mass internment										
31	camps arbitrarily detaining as many as 1,800,000 Uyghurs, Kazakhs, Kyrgyz, and										
32	members of other Muslim minority groups who have been subjected to forced labor										
33	torture, political indoctrination, and severe human rights abuses; and

35	WHEREAS, the forced labor experienced by Uyghurs, Kazakhs, Kyrgyz, and										
36	members of other Muslim minority groups in the Xinjiang Uyghur Autonomous Region o										
37	the People's Republic of China is systematic and widespread and therefore constitutes ar										

atrocity within the meaning of section 6 of the Elie Wiesel Genocide and 9 Atrocities Prevention Act of 2018 (Public Law 115–441; 10 22 U.S.C. 2656 note); and

WHEREAS, there is a very high risk that many factories and other suppliers in the Xinjiang Uyghur Autonomous Region are exploiting forced labor, according to reports from researchers, media, and civil society groups. Audits to vet products and supply chains in the Xinjiang Uyghur Autonomous Region are not possible because of the extent to which forced labor has contaminated the regional economy, the mixing of involuntary labor with voluntary labor, and the inability of witnesses to speak freely about working conditions given heavy government surveillance and coercion, and the strong incentive of government officials to conceal government-sponsored forced labor; and

WHEREAS, the City hereby denounces the forced labor, torture, political indoctrination, and severe human rights abuses and religious persecution of minority Muslims in the Xinjiang Uyghur Autonomous Region of the People's Republic of China; and

WHEREAS, the City supports ensuring that goods made with forced labor in the Xinjiang Uyghur Autonomous Region do not enter the United States.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

Section 1. Recitals. That the recitals and findings contained above are hereby confirmed, adopted and incorporated herein.

Section 2. Condemnation. That the City Commission hereby condemns the forced labor within the Xinjiang Uyghur Autonomous Region's system of mass internment camps, and throughout the region, as is confirmed by the testimony of former camp detainees, satellite imagery, and official leaked documents from the Government of the People's Republic of China as part of a targeted campaign of repression of Muslim ethnic minorities.

 Section 3. Transmittal. The City Clerk is directed to transmit a copy of this Resolution to Senator Marco Rubio's Broward District Manager Ms. Gina Alonso, the Office of Governor Ron DeSantis, Broward County Mayor Dale Holness, the Board of
