21	agreements have already been evaluated by staff during the CCNA prequalification		
22	process; and

24	WHEREAS, the areas of design professional expertise needed include		
25	architecture, engineering, transportation consulting, surveying services, construction		
26	management, and planning; and

28	WHEREAS, the City utilizes professional services, as might be needed, through		
29	CSAs to be awarded under a Request for Proposals (RFP); and

31	WHEREAS, following best practices, the City released a new RFP to test the		
32	design professional industries and reviewed and ranked the proposals; and

34	WHEREAS, the City Manager/Executive Director will be authorized to approve		
35	Projects/Tasks/Services with a cost of less than their delegated spending authority; and

37	WHEREAS, pursuant to Chapter 23, Section 23-3 Competitive Bidding Required,		
38	Section 23-4 Formal Contract Procedure, and Section 23-5 Award of Contract, of the City		
39	of Hallandale Beach Code of Ordinances, the City Manager shall solicit formal proposals		
40	when the estimated design professional costs shall exceed their delegated spending		
41	authoritys; and

43	WHEREAS staff recommends that the City Commission authorize award RFP# FY		
44	2018-2019-012, Continuing Professional Architectural and Engineering Services, and		
45	authorize the City Manager to execute all related documents, including a main agreement		
46	outlining insurance and performance requirements.
