SHORT TITLE:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING AWARD OF BID # FY2019-2020-002, FOR THE CONSTRUCTION OF THE RAW WATER WELL #9, TO FLORIDA DESIGN DRILLING CORPORATION, THE LOWEST RESPONSIVE BIDDER, IN AN AMOUNT NOT-TO-EXCEED, \$1,719,300 (ONE MILLION SEVEN HUNDRED NINETEEN THOUSAND AND THREE HUNDRED DOLLARS) INCLUDING CONTINGENCY; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AN AGREEMENT WITH FLORIDA DESIGN DRILLING CORPORATION; AND PROVIDING AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

This agenda item seeks City Commission approval to award BID # FY2019-2020-002 – RAW WATER WELL #9, for the construction of the Raw Water Well # 9, to Florida Design Drilling Corporation, the lowest responsive bidder, in the amount of \$1,563,000. Staff seeks approval to add a 10% (\$156,300) contingency to the construction project and to authorize the City Manager and the City Attorney to negotiate an agreement with Florida Design Drilling Corporation for a not-to-exceed total of \$1,719,300.

Background:

The City of Hallandale Beach is increasing in population and development. In order to keep up with the demand on our water consumption the City will add an additional Biscayne Aquifer production well (PW #9) within the City's limits. (Exhibit 2).

Current Situation:

Staff has reviewed the bids and the attached Award Information Memorandum (Exhibit 3). The Department of Public Works recommends awarding BID # FY2019-2020-002 to the lowest responsive bidder, Florida Design Drilling Corporation.

Why Action is Necessary:

Pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000.00 shall be based on competitive bids. Furthermore, pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager, shall have the authority to recommend to the City Commission award of contracts.

Cost Benefit:

The Raw Water Well # 9 construction needs to be completed before 2022 in order for the City to meet its water permitting and demand requirements. The benefits from construction of the Raw Water Well #9 is that it will increase our water production which will ensure that the needs of increased development intensity are met throughout the City.

PROPOSED ACTION:

Staff recommends approval of the attached resolution awarding BID # FY2019-2020-002 – RAW WATER WELL #9, for the construction of the Raw Water Well # 9, to Florida Design Drilling Corporation, the lowest responsive bidder, in the amount \$1,563,000. Staff also recommends adding a 10% (\$156,300) contingency to the construction project and authorizing the City Manager and the City Attorney to negotiate an agreement with Florida Design Drilling Corporation for a not-to-exceed total of \$1,719,300.
