FOR AN AMOUNT NOT TO EXCEED SIXTY 9 THOUSAND (\$60,000.00) DOLLARS; AND PROVIDING FOR AN 10 EFFECTIVE DATE. 11 12 WHEREAS, pursuant to Section 23-4 of the City of Hallandale Beach Code, all purchases 13 of and contracts for equipment, supplies and contractual services, when the estimated cost shall 14 exceed \$50,000.00 shall be based wherever possible on competitive bids; and 15 16 WHEREAS, in preparation for the 2018 State Legislative Session, City Administration 17 released a Request for Proposal (RFP) #FY 2016-2017-010, State Lobbyist Services on July 5, 18 2017 to retain the services of a State Lobbyist Firm to assist with a variety of issues affecting the 19 City and its residents at a State level; and 20 WHEREAS, the City Commission, in Resolution 2017-104 authorized the award of a 21 contract including two option one-year renewals subject to City Commission approval; and 22 23 WHEREAS, the City Administration recommends that the City Commission authorize a 24 renewal for the 2019 Session State Lobbyist Services, to Ballard Partners, Inc. in an amount not 25 to exceed sixty thousand (\$60,000.00) dollars; and 26 27 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF 28 THE CITY OF HALLANDALE BEACH, FLORIDA: 29 30 SECTION 1. City Commission Action. The Mayor and City Commission authorizes a 31 one year extension for the 2019 Legislative Session for State Lobbyist Services to Ballard 32 Partners, Inc. in an amount not to exceed sixty thousand (\$60,000.00) dollars, encompassing all 33 services rendered prior to, during and after the legislative session for the second one-year term 34 as contemplated in RFP 2016-2017-010 and in Resolution 2017-104.
