15	WHEREAS, pursuant to Chapter 23, Section 23-4, Competitive Bidding Required,
16	all purchases of and contracts for equipment, supplies and contractual services, when the
17	estimated cost shall exceed \$50,000 shall be based on competitive bids. Furthermore,
18	pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager, shall have the
19	authority to recommend to the City Commission award of contracts; and

21	WHEREAS, in order to keep up with the City's water consumption demand, the
22	City is proposing to add an additional Biscayne Aquifer production well (PW #9) within the
23	City's limits; and
24	
25	WHEREAS, in order to covey the water from PW #9, the City must construct a
26	3,000 linear foot 12-inch pipeline connecting the new well PW #9 and the existing well PW
27	#8 to the City's Water Treatment Plant; and
28	
29	WHEREAS, the 12-inch raw water pipeline will increase water production, which
30	will ensure that the needs of increased development intensity are met throughout the City:

32	WHEREAS, the Department of Public Works recommends awarding BID #
33	FY2019-2020-005 to the lowest responsive bidder, Hinterland Group, Inc., in the amount
34	of \$587,806 (five hundred eighty-seven eight hundred six) dollars, approving a 10%
35	contingency in the amount of \$58,780 (fifty-eight thousand seven hundred eighty) dollars
36	for a not to exceed total of \$646,586 (six hundred forty-six five hundred eighty-six) dollars
37	and authorizing the City Manager to negotiate an agreement with Hinterland Group, Inc.

48	dollars for a not to exceed total of \$646,586 (six hundred forty-six thousand five hundred
49	eighty-six) dollars, and authorize the City Manager to negotiate an agreement with
50	Hinterland Group, Inc.
