RESOLUTION NO. 2020-

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING PURCHASE ORDER INCREASE OF \$200,000 (TWO HUNDRED THOUSAND) DOLLARS FOR SERVICES OF PROGRESSIVE WASTE SOLUTIONS OF FLORIDA, INC. D/B/A WASTE CONNECTIONS OF FLORIDA, FOR SOLID WASTE TRANSFER AND DISPOSAL AND RECYCLING SERVICES UNTIL THE END OF 2019-20; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Hallandale Beach City Commission entered into an Agreement with the predecessor in interest to Progressive Waste Solutions of Florida, Inc. on December 6, 2010, for transfer and disposal of solid waste and processing of single stream recyclables for an annual amount not to exceed \$1,125,000; and

WHEREAS, the Agreement was amended on August 8, 2012 and on January 16, 2014; and

WHEREAS, the City has seen an increase in sanitation accounts and expects an additional 1,600 tons of waste for disposal for FY2019-20; and

WHEREAS, due to such increase, City staff recommends that the City Commission authorize Purchase Order #20200504 by an amount not to exceed \$200,000 (two hundred thousand) dollars - from the contractual amount of \$1,125,000 to \$1,325,000.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

SECTION 2. The Mayor and City Commission hereby authorize the City Manager to execute a change order to increase Purchase Order #20200504 by an amount not to exceed \$200,000 (two hundred thousand) dollars - from \$1,125,000 to \$1,325,000 - for the services of Progressive Waste Solutions of Florida, Inc. D/B/A Waste Connections of Florida, in order to continue solid waste transfer and disposal services as well as recycling services.

SECTION 3. This Resolution shall take effect immediately upon its passage and adoption.
