9	WHEREAS, the Hallandale Beach Community Redevelopment Agency (CRA)
10	requested the City via its Planning and Zoning Division make changes to the existing land
11	development regulations to allow the use of temporary cargo containers in the
12	Fashion/Art/ Design (FADD) subdistrict of the Regional Activity Center (RAC) to
13 14	accommodate continued efforts in reshaping the FADD area; and
15	WHEREAS the proposed ordinance amends the zoning regulations for temporary
16 17	uses to allow cargo containers in the FADD for a period of up to 5 years; and
18	WHEREAS, in addition to the FADD, annual permits for uses lasting more than 30
19	day will be allowed subject to City Commission approval in properties zoned Planned
20	Local Activity Center (PLAC), Commercial Recreational Active (CR-A) and the Central
21	RAC/Greyhound Track subdistrict, that are entertainment and recreation destinations,
22	such as, Gulfstream Park and the Big Easy, subject to annual reviews and conditions; and
23	
24	WHEREAS, the proposed ordinance also specifically provides for food truck
25	events and establishes a process for temporary uses and special events lasting more
26	than 30 days subject to City Commission approval; and
27	
28	WHEREAS, the proposed code amendments will enhance areas of the City
29	intended to provide for a mix of uses, recreation and entertainment by allowing a variety
30	of temporary uses and events as determined by the City Commission consistent with the
31	City's Comprehensive Plan, Future Land Use Element, and will improve the overall quality
32 33	of life for the citizens within the City of Hallandale Beach; and
	WHEPERS the staff recommands establishing 1) on annual fee of one they cand
34 25	WHEREAS, the staff recommends establishing 1) an annual fee of one thousand two hundred dollars (\$1,200) for temporary use permits for over 30 days pursuant to the
35	two number dollars (\$1,200) for temporary use permits for over 50 days pursuant to the

Ordinance and 2) increasing the one-time application fee for annual permits to threehundred and fifty dollars (\$350).

47	permits to three hundred and fifty dollars (\$350).
