12 13	WHEREAS, pursuant to Section 23-4 of the City of Hallandale Beach Code, all purchases
14	of and contracts for equipment, supplies and contractual services, when the estimated cost shall
15	exceed \$50,000.00 shall be based wherever possible on competitive bids; and
16	
17	WHEREAS, in preparation for the 2018 State Legislative Session, City Administration
18	released a Request for Proposal (RFP) #FY 2016-2017-010, State Lobbyist Services on July 5,
19	2017 to retain the services of a State Lobbyist Firm to assist with a variety of issues affecting the
20	City and its residents at a State level; and
21	WHEREAS, the City Commission, in Resolution 2017-104 authorized the award of a
22	contract including two option one-year renewals subject to City Commission approval; and
23	
24	WHEREAS, the City approved the extension of the second one-year renewal in resolution
25	2020-105 for the 2020 Legislation Services
26	
27	WHEREAS, the City declared its emergency order on Marcy 9, 2020 in Executive Order
28	20-52, as a result of COVID19 waiving procurement formalities and requirements. The City
29	anticipates the release of the new RFP for state lobbyist services in September 2020, which will
30	not allow sufficient time to fully execute a new agreement prior to October 12, 2020, which
31 32	terminates the existing agreement; and
33	WHEREAS, City Administration is requesting to continue with Ballard Partners on a month
34	to month basis for the same cost of the current state lobbyist services of \$5,000 per month not to
35	exceed \$40,000 until new RFP is awarded and executed; and

37	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF
38	THE CITY OF HALLANDALE BEACH, FLORIDA:

40	SECTION 1. City Commission Action. The Mayor and City Commission authorize
41	waiver of procurement requirements and formalities pursuant to the declared state of emergency
42	and authorize a month to month extension for the 2020 Legislative Session for State Lobbyist
43	Services to Ballard Partners, Inc. in an amount not to exceed forty thousand (\$40,000.00) dollars,
44	encompassing all services rendered prior to, during and after the legislative session for the
45	second one-year term as contemplated in RFP 2016-2017-010 and in Resolution 2017-104. The
46	City Manager is further authorized to execute all related documents to effectuate this project.

48	SECTION 3. Effective Date. This Resolution shall take effect immediately upon its
49	passage and adoption.
