20	inspection services during the construction of the PW #9 project; and

22	WHEREAS, City staff recommends that the City Commission authorize the City
23	Manager to enter into an agreement with Hazen and Sawyer to provide inspection services
24	during the construction of the Raw Water Well #9 (PW #9) Project, in accordance with
25	RFP #2013-2014-006 - Continuing Services Contract - for a not-to-exceed total of
26	\$169,774 (one hundred sixty-nine thousand seven hundred seventy-four) dollars.

28	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY

33	SECTION 2. The Mayor and City Commission hereby authorize the City
34	Manager to enter into an agreement with Hazen and Sawyer to provide inspection services
35	during the construction of the Raw Water Well #9 (PW #9) Project, in accordance with
36	RFP #2013-2014-006 - Continuing Services Contract - for a not-to-exceed total of
37	\$169,774 (one hundred sixty-nine thousand seven hundred seventy-four) dollars .
