4 5 6 7 8 9	A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA APPROVING THE FIRST AMENDMENT TO PARTICIPATION AGREEMENT WITH BROWARD COUNTY FOR THE E911 REGIONAL COMMUNICATION SYSTEM; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE
11	WHEREAS, Broward County owns and oversees the regional E-911 consolidated
12	communications system, which provides for the operations ad technological infrastructure
13	to support 911 call taking, computer-aided dispatch, and other functionality necessary for
14	the operation of public safety answering points (PSAPs), as well as countywide
15	interoperable public safety intranet that supports closet unit response in life-threatening
16	emergencies and regional specialty teams; and
17	
18	WHEREAS, the City approved the initial participation agreement pursuant to
19	Resolution 2013-88; and
20	
21	WHEREAS, pursuant to an Operator Agreement executed between the County
22	and the Broward Sheriff's Office (BSO), the County engaged the services of BSO to staff
23	and operate the regional PSAPs. The County and BSO intend to amend the Operator
24	Agreement to continue the services of BSO as the operator of the System, to update the
25	performance standards as recommended by Fitch & Associates, to ensure compliance
26	with Criminal Justice Information System (CJIS) or Florida Department of Law
27	Enforcement (FDLE) requirements, to establish an engagement process, to permit
28	municipalities to procure special municipal services above the base level of services
29	otherwise provided by the Operator, and to clarify the division of responsibilities of the
30	parties.; and
31	
32	WHEREAS, amendments to the Participation Agreement are necessary to
33	acknowledge and adopt the updates to the Operator Agreement and the operation of the
34	System including updated performance standards, current policies and standard operation

procedures, revised engagement process and role of the operational review teams, and

36	the demarcation points for the updated fire station alerting system, and to amend the RILA
37	to remain consistent with the Participation Agreement.; and

39	WHEREAS, the Mayor and City Commission desire to approve the First
40	Amendment to the Participation Agreement with Broward County, in substantially the
41	same form as attached Exhibit A; and

43	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
44	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

46	SECTION 1. The foregoing "Whereas" clauses are incorporated herein.
47	
48	SECTION 2. The Mayor and City Commission hereby approve the First
49	Amendment to the Participation Agreement with Broward County, in substantially the
50	same form as attached Exhibit A and authorize the City Manager to execute all related
51	documents.

53	SECTION 3. Effective Date. This Resolution shall take effect immediately upon
54	its passage and adoption.
