WHEREAS, Section 163.400, Florida Statutes, known as Cooperation by Public Bodies, encourages municipalities to do any and all things necessary to aid or cooperate in the planning or carrying out of a community redevelopment plan and related redevelopment activities; and

WHEREAS, the Board of Directors of the HBCRA desires to approve the Interlocal Agreements relating to the provision of indirect and direct services by the City to the HBCRA, all in substantially the form attached hereto as Exhibit "A" and by this reference made a part hereof.

NOW, THEREFORE, BE IT RESOLVED BY THE CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY:

- Section 1. Recitals. The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.
- Section 2. <u>Approval of Interlocal Agreements</u>. The Interlocal Agreements all as attached hereto as Exhibit "A" are hereby approved together with such non-material changes as may be requested by the City and acceptable to the Executive Director and approved as to form and legality by the HBCRA Attorney.
- Section 3. <u>Execution of Interlocal Agreements</u>. The HBCRA Executive Director is hereby authorized to execute the Interlocal Agreements.
 - Section 4. <u>Implementation of Interlocal Agreements</u>. The HBCRA Executive Director is hereby authorized to take all steps necessary and appropriate to implement the terms and conditions of the Interlocal Agreements, but not limited to, making payments to the City.
