14	WHEREAS, pursuant to Chapter 23, Section 23-8 (6) Exception to bid requirements, and
15	Section 23-9 Cooperative Purchasing, the City Manager is authorized to procure supplies,
16	materials, equipment and services from other governmental units and cooperatives, when the
17	best interests of the City would be served; and

19	WHEREAS, on September 18, 2019, City Commission approved Resolution No. 2019-
20	069, which authorized the City's piggyback of the Florida Municipal Power Agency (FMPA)
21	agreement with ENCO Utility Services, LLC; and

23	WHEREAS, the FMPA agreement with ENCO Utility Services, LLC is for an initial period
24	of five (5) years effective on the contract execution date of August 10, 2018 through August 2023
25	and

27	WHEREAS, the City has reviewed various contracts for utility billing printing/mailing
28	services and find that piggybacking off the FMPA contract with ENCO Utility Services is most cost
29	effective for the City; and
30 31	WHEREAS, the City Administration recommends that the City Commission authorize the
32	City Manager to piggyback the Florida Municipal Power Agency contract with ENCO Utility
33	Services, LLC for utility billing, printing/mailing services for an amount as provided for in Fiscal
