# **SHORT TITLE:**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE UTILIZATION OF THE SOURCEWELL CONTRACT #121218-WWG WITH W. W. GRAINGER, INC. FOR MAINTENANCE, REPAIRS AND OPERATIONS SUPPLIES, INDUSTRIAL EQUIPMENT AND TOOLS FOR AN AMOUNT NOT TO EXCEED ONE HUNDRED TWO THOUSAND ONE HUNDRED (\$102,100.00) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PURCHASE; AND PROVIDING AN EFFECTIVE DATE.

## **STAFF SUMMARY:**

### **Summary:**

Each fiscal year, the Procurement Department facilitates the purchase of specific commodities that the City procures annually through cooperative purchasing. As a member of Sourcewell, the City is able to participate and utilize competitively solicited contracts to obtain the best goods/services and pricing available in the market. The City wishes to purchase various items through <u>W.W. Grainger</u> as described below.

#### **Background:**

The contract term for W.W. Grainger Contract/RFP # 121218 is from January 25, 2019 through January 25, 2023.

Some of the purchases made by Departments utilizing this contract include but are not limited to, electrical supplies, mechanical equipment, hand soap, pumps, incandescent light bulbs, and mats of all kinds. These items can be purchased from the store located in Pompano Beach and/or online.

## **Current Situation:**
