A JOINT RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FL AND THE CHAIR AND BOARD OF DIRECTORS OF THE GOLDEN ISLES SAFE NEIGHBORHOOD DISTRICT, RELATING TO THE GOLDEN ISLES SAFE NEIGHBORHOOD DISTRICT; REPEALING RESOLUTION NO. 2018-028; AMENDING THE NUMBER OF MEMBERS OF THE ADVISORY COUNCIL; ESTABLISHING QUORUM REQUIREMENTS

WHEREAS, Ordinance 89-24 created the Golden Isles Safe Neighborhood District and established an Advisory Council comprised of five (5) property owners or residents of the District, whose appointments and responsibilities were created by Resolution No. 89-30; and

WHEREAS, by Resolution No. 2006-04, the City Commission, which serves as the Board of Directors of the District, repealed Section 1 of Resolution No. 89-30 to amend the number of members of the Advisory Council to one (1) member from each street within the neighborhood, serving at the pleasure of the Board of Directors; and

WHEREAS, Resolution 2011-25 reduced the number of members to 7 and repealed Resolution 2006-04; and

WHEREAS, Resolution 2018-028 reduced the number of members to 5; and

WHEREAS, the City Commission desires to amend the composition of the Advisory Council, to establish a quorum requirement to ensure proper representation and to centralize advisory board requirements for the district in a single resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. Resolutions No. 2011-25 and 89-30 continue to be repealed in their entirety. Resolution No. 2018-028 is hereby repealed and replaced.

SECTION 2. COMPOSITION OF ADVISORY COUNCIL

40
41 A. An Advisory Council to the Board of Directors of the Golden Isles Safe
42 Neighborhood District shall be comprised of seven (7) members who are residents of the Golden
43 Isles Safe Neighborhood.

44 B. Each member of the Board of Directors shall nominate one (1) member to the
45 Advisory Council in accordance with the general appointment process and term for City of
46 Hallandale Beach advisory boards and committees. All appointees serve at the will of the Board
47 of Directors.

48 C. Four (4) Advisory Council Members shall constitute a quorum for the conduct of
49 the Advisory Council's business.

50
51 **SECTION 3.** The Advisory Council shall abide by the following Bylaws which outline the
52 duties prescribed by the Board of Directors and shall include the following:

53
54 A. Review, in an advisory capacity, in public session, with City representatives, a Safe
55 Neighborhood Improvement Plan, District Budget and improvements, District Bylaws,
56 and related matters, as necessary for consideration and approval of the Board of
57 Directors.

58 B. Consult with City representatives at least once per year regarding the Safe
59 Neighborhood Plan for the District, the District budget and improvements and related
60 matters.

61 C. Prepare an annual report on the District's activities in accordance with the annual
62 report cycle of City advisory boards and committees.

63 D. In fulfillment of duties, request City Manager assistance through the Board of Directors.

64 E. Prepare reports and records as required of all general City advisory boards and
65 committees.

67 **SECTION 4.** This Resolution shall become effective upon its passage and adoption by
68 the City Commission.
