25	WHEREAS, Police Department's (HBPD) Strategic Intelligence Unit (SIU) has an ongoing
26	need to rent vehicles for their day-to-day operations. The ability to maintain an active rotation of
27	unmarked, indistinguishable "police" vehicles for use in patrol and undercover operations makes
28	it less likely that officers are recognized, which is a key element to the success of such operations,
